3.0 BUSINESS OF THE MEETING

3.1 Client Experience story

- This client experience story was shared by Director of Congregate Living and Emergency Housing and refers to a client of SHIPs Assertive Community Treatment Team (ACTT)
- The client was living in the community and was unable to maintain her unit and eventually referred to SHIPs Short Stay Crisis Support Program (Crisis Beds). The client was at the crisis bed program for an extended period and eventually placed at Peace Ranch where she currently resides.
- The client is not flourishing at Peace Ranch and a referral into SHIPs Community Homes for Opportunity (CHO) is currently being explored as there are neurodevelopmental and a psychiatric diagnosis to consider.
- The reason this story was shared with the board is because it shows how SHIPs fulsome continuum of housing and accompanying supports is client driven and focused – clients can go from community to crisis-based services and onto longer term transitional supports, to specialized supports such as CHO.

3.2 CEO Report

- This report covers November 21 to December 6. The past month focused on accreditation and continued community engagement.
- The CEO highlighted the following from the report:
 - 236 First Street: Work continues to progress with opening still planned for early 2024. Thomas and Cory continue to work with our lawyer to provide all of the required documents for the CMHC Loan Agreement
 - 273 Main Street: After receiving a summary of finding from our planners, they have recommended a meeting with the Town of Caledon to further explore the viability of this project.
 - SHIP won the annual award from Charity Village for being the Best Non-profit Employer – DEI (20+ Staff).
 - On November 29th, SHIP presented on the Safebed program to an Inter-ministerial Committee made up of leaders from a number of different ministries. We presented on SHIP, the Safebed history, program pressures, our engagement with the police and the hospitals and SHIPs unique model.

3.3 Housing and Homelessness Presentation

- The director of Congregate Living and Emergency Housing and the Director of Housing and Service Innovation presented on Housing and Homelessness.
 - Key take aways:
 - SHIPs model offers a unique spectrum of integrated housing and services that address the wellbeing of our clients through their life span
 - We deliver a continuum of housing and services to support people based on their needs.
